The Meta Pixel is a tracking tool that allows us to measure the effectiveness of our advertising by understanding the actions people take on our website. The Meta Pixel may collect information such as your IP address, time, referring website, browser type, and pages visited.

You can control cookies through your browser settings. However, disabling cookies may limit your ability to use certain features of our website.

6. DISCLOSURE OF YOUR INFORMATION

We do not sell, trade, or otherwise transfer your personal information to outside parties except as described below:

- **Service Providers**: We may share your information with trusted third parties who assist us in operating our website, conducting our business, or providing services to you (such as Meta for advertising purposes).
